

OFFICIAL CONTEST RULES Expogain Contest – Win \$5,000 in Expert Al Development Services

#### **1. SPONSOR**

The "Expogain AI Development Contest" (the "Contest") is sponsored by Expogain International Inc., c/o Web Conductors Inc., 46 Caplan Ave, Unit 4, Barrie, ON L4N 9J2 (the "Sponsor").

## 2. ELIGIBILITY

The Contest is open to legal residents of Ontario who are the age of majority at the time of entry and have completed the AI Opportunity Assessment (AIOA) offered by Expogain. Employees of the Sponsor, its affiliates, advertising and promotional agencies, and their immediate household members are not eligible to enter. ## 3. HOW TO ENTER

To enter, eligible participants must:

- Complete the AI Opportunity Assessment in full.
- Record a video (30 seconds maximum) explaining which insight from their report matters most to their business.
- Upload the video to a cloud hosting provider of their choice (e.g., Dropbox, Google Drive, or another platform).
- Email a public (shareable) link to the video to **aioa@expogain.com** with the subject line: **"AIOA Review"**.

Note: Expogain is not affiliated with Dropbox, Google Drive, or any other third-party hosting service. Participants are responsible for reviewing and complying with the terms and conditions of their chosen file-sharing platform.

Limit: One (1) entry per business. Duplicate entries will be disqualified.

# 4. CONTEST PERIOD

The Contest begins on the day the participant receives their AIOA report and ends **two (2)** weeks thereafter at 11:59 PM EST. Late entries will not be accepted.

#### **5. WINNER SELECTION**

All eligible submissions will be reviewed for clarity, relevance, and originality. One (1) winner will be selected by a panel of judges appointed by the Sponsor. The winner will be contacted via email within five (5) business days of the contest end date.

To claim the prize, the selected participant must:

- Correctly answer a skill-testing question,
- Confirm eligibility,
- Sign a Declaration and Release form.

If the selected participant does not respond within 48 hours, the prize may be forfeited and awarded to an alternate entrant.

#### 6. PRIZE

One (1) winner will receive up to **\$5,000 CAD** in AI development and implementation services provided by Expogain.

The prize must be used toward executing an initiative recommended in the winner's AI Opportunity Assessment. It is non-transferable, non-exchangeable, and not redeemable for cash. Services must be initiated within 90 days of winner confirmation.
